- 7. Considering the Revised feedback from stakeholders of TNOU and formulating the revised feedback mechanism in enhancing the quality of education, improving support services, and addressing the needs of learners and stakeholders effectively.

8. Initiating signing of MoU with other institutions for fostering and developing the cooperative relationship among Universities in terms of academic, support services, research, skill development, sharing ICT facilities, and extension activities.
